KUZHIMBULA

Chota cha Human Rights Commision (HRC – Z/Commis-sion) hichota chetung’a chinakutala hadi kukasunuka chawantu cha National Human Rights Institution (NHRI) chatung’iliwu munshimbi ya kapetulu 230(1) ya mumu-kanda wa nshimbi yetung’a da Zambia (kubombelaku nshimbi) ya nambala 2 yamuchaka cha 2016 namudimu wakuking’a kukasunuka chawantu.

Kubombelahu hanshimbi zhidi mumukanda wanshim-bi wa constitution,Nyidimu ni ng’ovu ya chota zhekala munyikanda yamboka ya nshimbi zhakutung’a mwitala da nshimbi zhidi neyi:

.Nshimbi ya Human Rights Commision nambala 4 yamu chaka cha 2024.

.Nshimbi yakutambula nsang’u ya Access to Information nambala 24 yamuchaka cha 2023.

Kutwalekahu,Kutung’ewa ni nyidimu ya chota ayilombol-ang’a kudi chota cha UN General Assembly Resolution 48/134 yaditezheliwu hefuku da 20 December 1993,kwat-abikang’awu nawu Paris Principles.

Ayinka nsona ya ‘A’ munlong’eshelu ya chota cha UN mu-long’a nyidimu yachu yaditezha nanyidimu ya chota cha UN Paris Principles.

Chota chekala membala wa chota chatalang’a hakukasun-uka chawantu mukabeta ka Africa cha Network of African National Human Rights Institutions (NANHRI) ni chota cha Global Alliance of National Human Rights Institutions (GANHRI).

NG’OVU YA CHOTA

Chota,hampinji yakuzata nyidimu yachi,hichikulombole-wang’a muzatilu yachu kudi muntu wacheng’iku.

MUDIMU WA CHOTA

Kapetulu 230 (3) kamumukanda wa nshimbi wa Consti-tution yetung’a da Zambia kalumbulula nyidimu ya chota cha Human Rights Commision yidi neyi;

- a) Kukeng’a wunsahu nikushimuna hadi kukabisha kukasunuka chawantu.
- b) Kulondela nzhila zhalumbuluka zhakukwashil-amu neyi kudi kuluwang’esha chakukasunuka chawantu.
- c) Kufwila kumanisha yinkonkozhola kuhitila mukushakama heseki nakuditezha hela ku-danakena;
- d) Kusanduzhola maana hadi kukasunuka cha-wantu ninsang’u zhinakundami kukukasanuka chawantu;
- e) Kutang’isha antu hadi kukasunuka chawan-tu;hamu
- f) Nikuzata nyidimu yikwawu neyi chinayilumbulu-liwu mu nshimbi

NYIDIMU YA CHOTA

Nyidimu yikwawu ya chota cha Human Rights Commission ayisoneka mu chibalu cha nshimbi ya kapetulu 6 kamu-kanda wa nshimbi wa Human Rights Act nambala 4 yamu chaka cha 2024 kwikala;

Kweseka nanshimbi yamukanda wa nshimbi wa Constitu-tion,nyidimu yikwawu ya chota yidi-

- a) Kuhenza henza wunsahu hadi kukabisha ku-kasunuka chawantu;
- b) Kusaduzhola maana hadi kukasunuka cha-

- wantu mwitung’a nikwidisha cha wunsahu wukufuma mukusanduzhola maana.
- c) Kulezha itung’a hadi kulondela kukasunuka chawantu mwitung’a.
- d) Kuya mutuleya,mutuleya twawanyana,nimalung’a makwawu mwakukasila antu ku-londa kupikita chinakuhembawu antu,kulon-da kukwasha maana hadi kumanisha kukala chinakutala hadi kubula kulondela kukasun-uka chawantu;
- e) Kuzatila hamu na nyitayi yamboka yatalang’a ha kuing’a kukasunuka chawantu muku-tung’a nshimbi zhinakundami kukukasunuka chawantu.
- f) Kuzatila hamu na nyitayi yamboka yat-alang’a hakuking’a kukasunuka chawantu mwitung’a,mukabeta,nihakachi kamatung’a;
- g) Kuwana nzhila zhakunung’ulwilamu nsang’u zhinakutala hakukasunuka chawantu niku-zatila hamu na nyitayi yatalang’a hakuking’a kukasunuka chawantu kulonda kwedesha nsang’u swayi.
- h) Kwidisha wunsahu wadimena wunakutala ha kukasunuka chawantu;
- i) Kukwasha maana hadi nshimbi zhinakutala hakuking’a kukasunuka chawantu mwitung’a
- j) Kuzatila hamu na mutayi wa Higher Educa-tion Authority ni nyitayi yikwawu kutung’a nlong’eshelu zhakutang’isha,kudizisa niku-sanduzhola maana hakukasunuka chawantu;
- k) Kulezha mutayi watelela hadi kuditezha chamatung’a hadi kukasunuka chawantu mwitung’a;
- 1) Kutala chinakulondela nfulumendi nshimbi zhakasa matung’a hakukasunuka chawantu
- 2) Chota, Munzatilu ya chu chinatweshi –
- a) Kutambula wunsahu wuchikumona kulema muzatilu yachu.
- b) Kutambula maana kufuma kunyitayi yikwawu hela kutambula mazu anakundami kuny-idimu ya chota kweseka na nshimbi;hela
- c) Kutambula wunsahu wakusoneka hela wakuhosha mukanwa kufuma kudi muntu wudi wezhima hela chota ha nyidimu ya chota kweseka namwaya nshimbi.

NG’OVU YAKUPIKITA

- Kapetulu 17 kamukanda wa nshimbi wa Human Rights Commision Kalumbulula ng’ovu yak-upikita nikwing’ila kwikala;
17. (1) Nkong’i wetezhewa natweshi,namudimu wakuking’a kukasunuka chawantu,hampinji yezhima yatelela,chakubula kulezha hela kwikala nachitupa chakwitezha,kwing’ila mwilung’a didi dezhima dinakukuhwelelayi nindi anakudizatisha hela akudizatisha kwil-ilamu mulong’a, kweseka naniwu mukanda wa nshimbi hela nshimbi yezhima yinakutala ha kukasunuka chawantu.
- (a) Kupikita ilung’a
- (b) Kupikita muntu wudi wezhima hanodi ilung’a neyi nkong’i wetezhewa nakuhweleli nindi,-muntu wudi nayipapilu,hela chuma che-zhima chinatweshi kukwasha mumudimu

- wakuhenza henza nsang’u ,llang’a muntu watela hohu kumupikita kudi mukwawu mu-katata hela mukwawu mukamama;
- (c) Kutambula yipapilu,mukanda hela chuma che-zhima chikukwasha mumudimu wakuhenza henza wunsawu; hela
- (d) Kwihula kulonda kwiluka walala neyi kukasun-uka chawantu chinakabishewi.
- (2) Chota chanyilong’a chinatweshi kuhana chitupa kudi nkong’i neyi chinamwekani nawu wun-sahu wakusoneka wunahanewi kudi nkong’i hanyima yakusanyika,nakuhweleli nindi ku-kasunuka chawantu chinaluwang’eshewi hela anakukeng’a chiluwang’esha.
- (3) Nkong’i wetezhewa wunakuzata mudimu kwe-seka na nshimbi watela,henohu kanda atachiki kupikita ilung’a watela,kumona nindi,muntu washakamang’a munodi itala hela ilung’a wudi hohu.

(4) Nkong’i wetezhewa wukusenda chuma chezhima kufuma mwitala hela ilung’a watela –

(a) Kuhana chitupa cha lisiti hadi chuma chezhima chinasendiyi kudi mwini chuma hela muntu wudi nang’ovu hanodi ilung’a;hela

(b) Kufuntisha swayi swayi chuma chasendawu hanyima yakuzatisha chuma kweseka namudimu achisendelawu.

KULEMA CHA KUHENZA HENZA NSANG’U

Kapetulu 18 kamumukanda wa nshimbi wa Human Rights Commission kalumbulula kulema cha kuhen-zahenza wunsahu kwikala,

18.(1) Chota chikwikala nang’ovu ya kuhenzahenza kuluwang’esha cha kukasunuka chawantu –

(a) Chota chacheni chinatweshi kuwana nzhila yaku-tachikilamu; hela

(b) Neyi chinatambuli mwabu kufuma –

(i) Kudi muntu analuwang’eshiwu kukasunuka chindi;

(ii) Kuchota ,kwimenaku yota yikwawu;

(iii) Kuchota,kwimenaku muntu anabishiwu;hela

(iv)Kumuntu kwimenaku izamvu hela mukanka wawantu.

(2) Chota,mumudimu wachu wakuhenza henza nsang’u kweseka nakapetulu (1), chidi nang’ovu ya –

(a) Kuhana sayimoni kulonda kumwekena kumensu achota nikumwekesha wunsahu wakusoneka hela wunsahu wudi wezhima walema wunakundami kumudimu wakuhenza henza nsang’u wunakuzata chota;

(b) Kwihula muntu wezhima ha nsang’u yinakuhenza henzawu yidi mu chota;hela

(c) Kushimuna wunsahu wezhima wunelukiyi muntu hadi nsang’u yinakuhenza henzawu

(3) Muntu akutambikawu kwikala chinsahu kweseka nakapetulu kanyanya (2) watela kusanyika.
